**Withdrawing Nominations**

Nominations cannot be withdrawn after 12:00pm (AWST) on 08/05/2018.

**Candidate Statements**

Candidates may submit a statement to be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer by 12:00pm (AWST) on 15/05/2018 can be accepted. Candidates may submit a statement to be included with ballot material. To assist candidates, a standard Candidate Statement Form is available for use at [www.aec.gov.au](http://www.aec.gov.au)

**Voting Period**

The ballot, if required, will open on 05/06/2018 and close at 10:00am (AWST) on 26/06/2018.

**Scrutineers**

Each candidate may appoint, in writing, one person as scrutineer to represent the candidate's interests in the conduct of the ballot. A scrutineer shall not be a candidate for any position which is also included in a ballot in the election. The candidate may appoint one or more substitute scrutineers, if required.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
