Insufficient Nominations Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

Federal Office

- Branch Delegate to Federal Council (1)

Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 11/09/2024.

A nomination form is available for electronic completion on the AEC Portal, www.aec.gov.au/ieb/. However, the nomination form must then be lodged in accordance with the Organisation's rules. Additional forms are available from the Returning Officer. Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below before the closing of nominations by the Returning Officer at the Council Meeting to be held on **Wednesday 25 September** at approximately **12:00 noon** (AWST), 107 Abernethy Rd Belmont WA 6104.

How to lodge nominations, nominations must be lodged via the following method(s):

By Portal: Australian Electoral Commission Portal, www.aec.gov.au/ieb/

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to IEBnominations@aec.gov.au

The subject line of your email should include the reference: "E2024/35 WAPOU - Stage 2-Your Name".

In-Person: Before the nominations close at the Council meeting on 25/9/2024.

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 03 9285 7111 to enquire about the status of your nomination.

Withdrawing Nominations

Nominations cannot be withdrawn after the closing of nominations at the Council meeting on 25/09/2024.

Voting Period

The attendance ballot, if required, will open and close at the Council meeting on 25/09/2024. The meeting will be held at 107 Abernethy Rd Belmont WA 6104. The postal ballot, if required will open on 27/09/2024 and close at 10:00am Australian Eastern Standard Time (AEST) on 25 October 2024

Absent Voting

If a member who will be unable to attend the meeting at which the election is to be conducted, may apply to the returning officer for ballot material to be sent to an address that the member so nominates. The member needs to complete the Absentee application form and return it to the Returning Officer via email by 5:00pm Australian Eastern Standard Time (AEST) on 23 September 2024.

Scrutineers

The appointment of scrutineers opens on 11/09/2024. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
