## **Candidate Statements**

A candidate for a Group or Branch office may submit to the Returning Officer a biography and/or a statement in support of their candidature only, for distribution with the ballot material. The statement shall not exceed 200 words.

Only statements which comply with the Rules and are received by the Returning Officer by (Australian Western Standard Time (AWST)) on 11/10/2022 can be accepted.

## **Scrutineer Appointment**

Each candidate may appoint, in writing, one person as scrutineer to represent the candidate's interests in the conduct of the ballot. A scrutineer shall not be a candidate for any position which is also included in a ballot in the election. The candidate may appoint one or more substitute scrutineers, if required.
